Exhibit "A" to Bylaw 01-17

FIRE ASSOCIATION AGREEMENT BETWEEN:

THE RURAL MUNICIPALITY OF PARKDALE NO. 498 -ANDTHE VILLAGE OF GLASLYN

WHEREAS the parties, named above, desire to associate with each other for the purpose of organizing a Firefighting association, forming and dispatching a fire fighting brigade, maintaining and operating a Fire Hall and providing for the purchase of firefighting equipment to be used for the protection of persons and property within their corporate boundaries.

THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. This agreement is for a five (5) year term and revised and extended at the end of that term. This agreement is to become effective at the signing of this Agreement by both parties.
- 2. The "Fire Association" shall consist of all council members of the Rural Municipality of Parkdale No. 498 and the Village of Glaslyn.
- 3. A Fire Committee shall be formed consisting of the Reeve of the Rural Municipality of Parkdale No. 498, the Mayor of the Village of Glaslyn and the Fire Chief or any one of the Deputy Fire Chiefs.
- 4. The Fire Committee shall meet at least once in each calendar year for the purpose of considering any capital expenditures or necessary maintenance expenditures to be made in regard to the provision of firefighting services and shall provide a report of their meeting to the councils of each municipality for consideration in each annual operating budget and all approved expenditures shall be shared equally.
- 5. The Village of Glaslyn shall establish a Fire Brigade by appointing a Fire Chief and as many fire fighters and other assistants that both parties to this agreement may consider necessary to provide sufficient firefighting services.
- 6. The Village of Glaslyn shall be responsible for the dispatching of equipment and the fire brigade.
- 7. The Village of Glaslyn shall house the fire trucks and equipment in a heated building. The Rural Municipality of Parkdale No. 498 agrees to pay ¼ (one quarter) of the annual costs associated with the power and energy utility expenses on that building.
- 8. The Village of Glaslyn shall pay the cost of insurance coverage for the equipment and members of the Fire Brigades and the RM of Parkdale agrees to pay ½ (one half) of this cost on an annual basis.
- 9. The Rural Municipality of Parkdale shall be responsible in paying for all costs associated with the Fire Association, including but not limited to, the costs for maintenance and capital purchases of equipment, as well as reimbursements to the fire brigade as set out in clause 21. The Village of Glaslyn agrees to pay ½ (one half) of the above costs, after revenues, on an annual basis.
- 10. The Fire Chief and/or the Deputy Fire Chief(s) shall receive prior approval from the Fire Association for payment of expenses relating to training of personnel for fighting fires and for the maintenance or replacement of all fire equipment.
- The Fire Chief shall make a weekly fire check of all fire or rescue vehicles and related equipment and have ready at all times.
- The Fire Chief shall be responsible to see that the cleaning, drying and inventory of all vehicles and equipment be done after each and every use.
- The Fire Chief shall use his discretion in the use of the fire engines or rescue vehicles in the event of simultaneous fires.
- 14. In the event that our Fire Brigade responds to a fire scene on a highway right-of-way or Crown Land, the Fire Chief or Deputy Fire Chief in charge shall ensure that Saskatchewan Environment is advised immediately as required by their policy for approving payment for this service.
- The Fire Association, Fire Committee, Fire Chief, Deputy Fire Chiefs or the Fire Brigade shall not be responsible for any loss under any condition.
- 16. The Fire Chief shall submit a report to the Village of Glaslyn and the RM of Parkdale as soon as deemed possible following the dispatch of any part of the Fire Brigade and/or equipment.

Just Just

- The RM of Parkdale shall invoice the Village of Glaslyn for any Fire Brigade call outs within the jurisdiction of the Village of Glaslyn, at the rates shown in clause 20, and Village of Glaslyn shall remit payment of the invoiced amount to the RM of Parkdale and shall be responsible for recovering that expense by invoicing the appropriate person(s) and/or by adding that expense to their property tax.
- 17. The RM of Parkdale shall invoice the appropriate person (s) for any Fire Brigade call outs within the jurisdiction of the RM of Parkdale, at the rates shown in clause 20, and/or by adding that expense to their property tax.
- The RM of Parkdale shall issue invoices for all fires that are attended to by the Fire Brigade outside the boundaries of the Rural Municipality of Parkdale No. 498 at the rates shown in clause 20.
- 19. All revenue collected by the RM of Parkdale as a result of invoiced services within the corporate boundaries of the Village of Glaslyn, the Rural Municipality of Parkdale No. 498 or outside the corporate boundaries of the Rural Municipality of Parkdale No. 498 shall be used to offset the expenditures of the operation of the Fire Association in each year and a detailed report of annual revenues and expenses supplied to the Fire Association.
- 20. The following fees shall apply to the dispatch of the Fire Brigade and equipment within the boundaries of the Village of Glaslyn or the Rural Municipality of Parkdale No. 498 or outside the Boundaries of the Rural Municipality of Parkdale No. 498 providing a mutual agreement is in place:
 - a) A fee of \$750.00 (seven hundred and fifty dollars) per hour for the dispatch of any of the fire engines, rescue vehicles or jaws of life.
 - b) An amount equal to the cost of any additional contractual service required in the dispatch of the Fire Brigade or the fire equipment.
 - c) A minimum call out fee of \$200.00 (two hundred) shall be applicable for all false alarm calls to which the Fire Brigade responses to.
- 21. The following fees shall apply to payment to the members of the Fire Brigade:
 - a) A fee of \$30.00 (thirty dollars) per hour shall be charged for and remitted to the members of the Fire Brigade for attendance at all fires. The amount of men authorized to be billed for shall be determined and verified by the Fire Chief or Deputy Fire Chief and shall be remitted to each man on a quarterly basis;
 - An allowance for mileage shall be charged for and remitted to the members of our Fire Brigade which may make use of a personal vehicle for the transportation of members of the Fire Brigade. The amount of vehicles this allowance may be charged for or remitted on behalf of shall not exceed three vehicles. This allowance shall be charged for at a rate of \$0.50(fifty cents) per kilometer. The vehicle allowance shall be paid on a quarterly basis to the individuals involved following written documentation of the Fire Chief or Deputy Fire Chief;
 - c) The Fire Chief shall be paid a remuneration of \$100.00 (one hundred) per month to be reviewed annually.

22. If, for any reason, it is necessary to dissolve this agreement, the assets that are available shall be purchased by either party at a price which is agreeable to both parties and not greater than the appraised value at that time. All appraisals shall be made by an independent appraiser.
